### **APPLICATION DOMAIN:**

pro|T|co cleaner 3D is suitable for pre-process cleaning Pro-T-co. It strips concrete, cement, stripping or storage oils on building materials, BPE plants, etc ...

# **USER MANUAL:**

Ready to use, the pro|T|co cleaner 3D is used with a low pressure sprayer. Coat the surfaces to be



cleaned, insisting on the most important thicknesses. Let pro|T|co cleaner 3D work from 10 to 60' for fat and milt. To destructure the larger concrete residue or to rust out corrosion points, it must be left to act for up to 48 hours \*. The product does not attack steels, aluminum, plastics or rubbers thanks to the inhibitor contained in its formula. However,

the product should not be applied to galvanized steels at the risk of removing the surface treatment. It is imperative to rinse with water and / or with the high pressure cleaner for an optimal result.
